Deadline for questions to be placed on the Primary Election ballot

No Party Affiliation changes from June 1st through September 1st – Unaffiliated voters can affiliate at any time. KSA 25-3304(b)

July 14

Registration books close – last day to register KSA 25-2311(3)

July 15

Advance voting by mail begins – 20 day prior to Election Day KSA 25-1123(a)
Advance voting in person may begin at County Clerk's office

July 20

Advance voting in person must begin in County Clerk's office (15 days prior to Election Day)

August 3

Advance voting in person closes (12 noon) KSA 25-1122(g)
Filing deadline for Independent nominations (12 noon) KSA 25-305(b)
Filing deadline for District Court Retention of Judges (12 noon) – KSA 20-2908

August 4
